## Murder suspects jailed

**WILLISTON – The two men suspected of murder are in the Levy County Jail now, according to an updated from the Williston Police Department.**

Williston Police Chief Moshoji J. “Mike” Rolls issued a warning to two suspected murderers as well as other members of the criminal element on Feb. 16.

On Feb. 24 one of the two suspected killers -- Kentavious Demarous Brown was put in jail, according to a press release from Chief Rolls. The other suspected first degree murder suspect -- Isaac Mitchell Williams was put in jail recently, the WPD announced in a Feb. 27 press release..

With the assistance of the United States Marshals Florida Caribbean Regional Fugitive Task Force, the Levy County Sheriff's Office and the Williston Police Department, Chief Rolls said on Friday (Feb. 24), Brown is in custody.

A reward is being offered for information about the remaining suspect. Contact Crime Stoppers at 1-877-349-8477.

There is a \$3,000 reward for information leading to the arrest of Williams.

In his Feb. 16 press release, WPD Police Chief Rolls first noted his condolences to the family of the late Malik Jamar Hall, 26, who died Feb. 7. Hall was a 2015 graduate from Williston High School.

As a result of the teamwork by members of the Williston Police Department, led by Chief Rolls, the Levy County Sheriff's Office, under the leadership of Levy County Sheriff Robert B. “Bobby” McCallum Jr., and with the help of the Eighth Judicial Circuit State Attorney's Office, under the leadership of State Attorney Brian Stuart Kramer, two

suspected murders are now being sought, Rolls noted the Feb. 16 press release.

The Williston police chief thanked the LCSO and SAO for those agencies' assistance in reaching this point in this case of first degree premeditated murder.

First degree premeditated murder arrest warrants were issued Feb. 16 for Kentavious Demarous Brown, 22, and Isaac Mitchell Williams, 20, both of Williston, according to records.

There are two maximum penalties for this crime in Florida – death by execution or life in the state prison system, according to Florida statute.

Brown has two nicknames or aliases – Tay and Luhh Slezzy, according to Chief Rolls.

Williams is also known as Buss Out, Rolls said.

These suspected murderers should be considered armed and dangerous, Rolls said.

“So, wannabe gangbangers, drug dealers, burglars, thieves and all others, this is your official warning. You are not wanted in our communities, and if you choose to stay, look over your shoulders because we are coming.”

The chief went on to note “We will not tolerate this in our community.”
